


#### **PORTFOLIO BY SECURITY TYPE**

Total Market Value \$3,172,348,793




#### **PORTFOLIO BY FUND TYPE**

Total Market Value \$3,172,348,793




#### **INVESTMENTS MATURING WITHIN 18 MONTHS**
