Executive Summary

In 2008, the General Assembly of the State of Colorado enacted the Building Excellent Schools Today Act, known as “BEST,” in order to repair or replace Colorado’s most needy public school facilities. The Colorado Department of Education’s Division of Capital Construction manages BEST — a competitive grant program available to all public school districts, charter schools, institute charter schools, boards of cooperative educational services and the Colorado School for the Deaf and Blind.

Applications are reviewed on a yearly cycle and recommended for funding by the Capital Construction Assistance Board (CCAB)—a nine-member appointed board that, in conjunction with staff, reviews grant applications for the current fiscal year. The Division has eight in-house assessors working to complete condition assessments and adequacy surveys for every facility in the state by 2022, and to reassess every five years thereafter to help the CCAB make informed decisions.

BEST is funded through multiple revenue sources: State Land Board proceeds, marijuana excise tax, Colorado Lottery spillover funds, and interest accrued in the Public School Capital Construction Assistance Fund. Matching funds are required by statute and calculated based on a series of factors, from the district’s bond election efforts over the past 10 years to the district’s assessed value per pupil.

This BEST Annual Report is submitted to the General Assembly pursuant to Section 22-43-7-111, C.R.S.

BEST FY2019-20 Grant Projects which Received Funding - Summaries

Meeker RE1-HS Renovation & Addition

This project addresses health, safety, and technology deficiencies by renovating a portion of the existing Meeker High School, adding new classrooms and other program elements, and then removing a portion of the building. The current high school building has a long list of deficiencies; the portion of the building that will be removed could not be corrected by renovation as the plan itself is part of the problem. This project will enhance student achievement by providing students with classrooms constructed to current educational standards. For example, students will no longer have to learn science in 1956 original science classrooms that have never been remodeled.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$7,529,595.31; District Contribution \$32,099,853.69 or 81%, with the source of match being the district's 2018 bond proceed fund.

Lewis-Palmer 38/Ray Kilmer Elementary School Boiler Replacement

This project addresses health and safety of a deficient boiler at the school which is located at the eastern most school in the district where the weather is severe. The existing boiler system is no longer functioning at the optimum capacity and is prone to stop firing. The project will replace the boiler system with two energy efficient boilers and repair any areas affected by this replacement. The replacement of the boiler will provide students with a dependent and temperature appropriate environment. The project will have a construction warranty and the selected boilers will have a manufacturer's warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$140,049.66; District Contribution \$297,605.54 or 68%, with the source of match being the district's general fund.

Pritchett RE-3/Building System/ Safety Upgrades

This project addresses upgrading the existing original mechanical systems from 1929 and 1962 which operate on a limited capacity. This lends the building to not provide appropriate heating and students to wear jackets in the cold season. This project will resolve these deficiencies by designing a system that will take into consideration energy efficiency and building envelope. The system will provide the appropriate heating and cooling of the



building to enhance occupant comfort. Additionally the electrical system will be upgraded for the new system requirements and added electrical capacity. The project will have a construction warranty and also manufacturer warranties for the products included in the construction.

This project is recommended for BEST Cash funding as follows:

Grant \$3,910,681.65; District Contribution \$205,825.35 or 5%, with the source of match being the district funds and a lease purchase funded by an energy performance contract.

Granada RE-1/Building System/Safety Upgrades

This project addresses indoor air quality, an obsolete mechanical system, hazardous materials and building safety issues including backup power. This project will resolve these deficiencies and enhance student achievement by designing an energy efficient mechanical system that will address the heating and cooling of the building including upgrading the building envelope to support the new mechanical design. This project will provide the appropriate temperatures to enhance student learning and occupant comfort. The project will include a construction warranty and a manufacturer's warranty on products included in the construction.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$3,361,303.54; District Contribution \$2,335,821.10 or 41%, with the source of match being the lease purchase financing and district funds.

Monte Vista C-8/Delta Center Roof Replacement

This project addresses health and safety deficiencies by replacing the roof on this school that has been in continual use as a school for ninety-three years. The water saturated roofing will be replaced entirely and the new roof will carry a twenty-year no cost warranty. This project will provide a weather tight roof surface and restore water damaged interior finishes.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$131,891.25; District Contribution \$43,963.75 or 25%, with the source of match being the district's general fund.

Eaton RE-2/K-12 Secure Entries

This project addresses health and safety deficiencies including security concerns at all schools in the district. Currently all schools are lacking secured vestibules to control access and have various degrees of uncontrolled access points around the campuses. This project will resolve these deficiencies and enhance student achievement by providing secure vestibules at all schools with direct access control and a visitor management system, as well as placing strategically located cameras and door position switches to monitor and control secondary entrances.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$478,886.40; District Contribution \$1,516,473.60 or 76%, with the source of match being a 2019 Bond Election or the district's general fund.

Durango 9-R/Animas Elementary School Boiler Replacement

This project addresses health and safety deficiencies by replacing the Animas Elementary School's boilers and main circulation pumps that are at the end of their useful life. This project will enhance student achievement replacing the boilers prior to failure causing an emergency and potential closure of the school for lack of heat.



The new boilers will have a one year contractor's warranty and a ten year manufacturer's warranty, plus the new boilers will be more efficient saving energy costs.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$87,773.02; District Contribution \$214,892.55 or 71%, with the source of match being the district's Capital Renewal fund.

South Routt School District RE-3/High School Roof Replacement

This project addresses health and safety by replacing the aged and deteriorated roof on Soroco High School. The existing roof is leaking and causing damage to the building. Current roof is beyond repair due to multiple layers, leaks are saturating the underlayment, and water is ponding on the roof causing live load concerns. This project will enhance student achievement by eliminating the distraction of leaking roofs and on-going maintenance efforts. New roof will have additional insulation and a 20-year warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$289,332.96; District Contribution \$227,333.04 or 44%, with the source of match being the district's general fund.

Byers 32J/Asbestos Abatement

This project addresses health and safety deficiencies including asbestos containing floor tile adhered to deteriorated carpet in hallway areas of the school. The carpet is beyond its life and cannot be repaired or replaced without dislodging asbestos, so abatement is necessary. This project will resolve these deficiencies and enhance student achievement by removing the asbestos-containing tile in affected areas and replacing the flooring.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$35,668.36; District Contribution \$51,327.64 or 59%, with the source of match being the district's general fund.

Lewis-Palmer 38/Prairie Winds Elementary School Roof Replacement

This project addresses health and safety concerns from a leaking roof. The roof is no longer under a warranty. The district has continued to patch the existing roof but are no longer successful. During a weather event the district has to address where a leak occurs which impacts student daily activities. The area must be dried out to prevent future mold from developing. The existing roof is in sections and will be replaced with asphalt shingles and a new ballasted ethylene propylene diene terpolymer (EPDM) roof system. The completion of this project will provide a weather tight environment for students and occupants. The roof systems will have minimum of a ten year warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$357,298.08; District Contribution \$759,258.42 or 68%, with the source of match being the district's general fund.

Cheraw 31/Building System/Security Upgrades

This project addresses a deficient mechanical system, a deficient plumbing which includes water quality concerns and the removal of hazardous materials which affects the health and safety of students and occupants. This project will resolve these deficiencies and enhance student achievement by providing a mechanical system



that will provide appropriate heating and cooling, replace existing plumbing piping to eliminate backups and concerns for water quality and install new carpet where the existing carpet is worn and glued to vinyl asbestos tile. The new mechanical system will be designed to address energy efficiency and meet current codes. The project will have a construction warranty and a manufacturer's warranty for all products installed.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$2,762,188.40; District Contribution \$1,183,795.03 or 30%, with the source of match being the district's general/ capital reserve fund.

Yuma 1/High School Addition/Renovation and Middle School Renovation

This project addresses health and safety deficiencies including electrical system failures and fires, multiple fundamental security deficiencies, health concerns, HVAC, and site safety issues. The high school's office is situated far from the entrance, and Vocational Agriculture building is housed in a separate deteriorating building across campus. This project will resolve these deficiencies and enhance student achievement by relocating the entrance and administration, adding a career-tech and athletic addition, renovating the existing building to resolve electrical, HVAC, security, and classroom functionality issues, and reorganizing the site layout to improve safety. Additional renovations will occur in the middle school to address electrical, kitchen food service and abatement, and site concerns.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$15,968,229.00; District Contribution \$15,968,229.00 or 50%, with the source of match being a November 2019 Matching Money Bond Election.

Hoehne Reorganized 3/Vocational-Agricultural Building Replacement

This project will replace the existing vocational-agricultural building that impacts the health and safety of students. The district engaged a design team which included a structural engineer to evaluate the existing conditions. The building was determined to be structurally unsound. The mechanical system that supports the specific use is not code compliant and the existing electrical does not support the specific equipment used by students for the classes. This project will resolve these deficiencies by constructing a new independent building that will be built to support vocational/ agricultural use and the specialized equipment. The project will include high performance design, energy efficiency and be code compliant. The project will have a construction warranty and a manufacturer's warranty for all products which will include the specialized equipment.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$1,775,689.27; District Contribution \$3,156,780.93 or 64%, with the source of match being a November 2019 bond election.

Colorado Springs 11 RJ Wasson Academic Campus System Upgrades

This project addresses water quality issues within the building which affects the health and safety of all occupants. The district had testing completed that identified lead and copper leaching which identified contamination throughout the cold-water distribution. The hot water lines, recirculating system and the boiler are also impacted by the cold-water system and will be replaced. This project will replace the existing contaminated piping and associated fixtures to provide for safe use of the water system by all occupants. The project will have a construction warranty and a manufacturer's warranty for products replaced in the facility.

This project is recommended for BEST Cash funding as follows:



Grant Amount \$1,566,281.20; District \$2,784,499.90 or 64%, with the source of match being the district's mill levy override funds.

Moffat County RE: NO 1–Elementary School Roof Replacement

This project addresses health and safety deficiencies by replacing the leaking metal roof panels on the Sunset Elementary School. This project will enhance student achievement by making the building weather tight, therefore eliminating the buckets around the building when it rains or during snow melt.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$835,225.00; District Contribution \$835,225.00 or 50%, with the source of match being the district's Capital Reserve fund.

Sheridan 2/ECC/SOAR Academy Roof Replacement

This project is the partial replacement of the roof system at the district Early Childhood Center and SOAR Academy building which affects all occupants every time there is a weather event. The district has patched the roof numerous times, but the fix is no longer maintaining and it is even more difficult for the district to locate the leaks. The new system will remove the existing system to deck. If any deck is damaged it will be replaced. The new system will include new insulation and a 60 millimeter ethylene propylene diene terpolymer (EPDM) membrane that will meet the current code requirements. A weather tight roof will allow occupants to focus on their learning in lieu of being relocated during weather events when the roof leaks. The project will have a 2 year leak free construction warranty and a 20 year manufacturer's warranty.

This project is recommended for BEST funding as follows:

Grant Amount \$930,876.66; District Contribution \$546,705.34 or 37%, with the source of match being the district's capital reserve fund.

Greeley 6/Scott Elementary School Roof Replacement

This project addresses health and safety deficiencies including ongoing roof leaks and roof deterioration, causing damage to classrooms and spaces below. The roof is over thirty years old and in poor condition, with additional drainage issues causing icy spots on walkways below. This project will resolve these deficiencies and enhance student achievement by replacing the roof and resolving drainage issues. The new roof will carry a ten year warranty and will be designed for a 20+ year life expectancy.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$597,001.05; District Contribution \$729,667.95 or 55%, with the source of match being the district's general fund mill levy override dollars.

Durango 9-R – DHS Fire Alarm and Intercom System Upgrade

This project addresses health, safety, and technology deficiencies by updating the Durango High School fire alarm panel and expanding the deployment of horn/strobe notifier devices throughout all areas of the school. The intercom system will also be updated and expanded for full coverage. This project will enhance student achievement by providing for clear notification during fire events and by assuring that messages over the intercom are heard by the students providing them current information and a greater sense of safety.

This project is recommended for BEST Cash funding as follows:



Grant Amount \$110,588.60; District Contribution \$270,751.40 or 71%, with the source of match being the district's Capital Renewal fund.

Douglas County RE 1/Trailblazer Elementary School Roof Replacement

This project will replace an existing leaking roof that impacts the health and safety of students. During a weather event the roof leaks into classrooms and other student spaces such that the district must relocate students that are impacted by the leaking roof. The areas affected by the leak must be cleaned such that no mold will grow and damage repaired. This project will remove the roof system down to deck. If the existing deck is damaged it will be replaced. The new system will include new insulation and a 60 millimeter ethylene propylene diene terpolymer (EPDM) membrane that will meet current code requirements. A new weather tight roof will allow students to be educated without the disruption of a leaky roof. The project will have a construction warranty and a manufacturer's warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$128,651.60; District Contribution \$514,606.40 or 80%, with the source of match being the district's November 2018 bond election.

Justice High School-High School Health, Safety & Adequacy Improvements

This project addresses health, safety, and technology deficiencies including fire alarm and exiting, security systems and door monitoring, ventilation system, hazardous materials, plumbing system, and electrical system. This project will resolve these deficiencies and enhance student achievement by replacing or modernizing the obsolete systems and making modifications to the interior layout to provide for better exiting, supervision, and learning environments.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$921,525.36; District Contribution \$1,081,790.64 or 54%, with the source of match being the Boulder Valley School District's General Fund.

Clear Creek RE-1-Elementary School Boiler Replacement

This project addresses health and safety deficiencies by replacing the Georgetown Community School's boilers that are at the end of their useful life. This project will resolve these deficiencies and enhance student achievement replacing the boilers prior to failure causing an emergency and potential closure of the school for lack of heat. The new boilers will have a one year contractor's warranty and a ten year manufacturer's warranty, plus the new boilers will be more efficient saving energy costs.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$117,042.48; District Contribution \$183,066.44 or 61%, with the source of match being the district's 2018 bond proceed fund.

Montrose County RE-1J-Roof Replacements 1High School, 1 Middle School/High School, 2 Elementary Schools

This project addresses health and safety by replacing six sections of roofing over five different schools. These roofs have multiple leaks that can no longer be repaired, and the leaks are disrupting the classroom learning environment. This project will install new roofing at the Olathe Middle/High School, Olathe Elementary School, Montrose High School, Centennial Middle School, and Cottonwood Elementary School. These schools hold over 53% of the district's student population. New weather tight roofs will dramatically improve the overall interior learning environment while also improving the building's energy performance. The new roof installations will



carry a five-year warranty from the contractor and a twenty-year full roofing system guarantee by the manufacturer.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$1,755,359.22; District Contribution \$2,864,007.14 or 62%, with the source of match being the district's bond reserve fund.

Montrose County RE-1J – Olathe Middle School HVAC Replacement

This project addresses health and safety by replacing four original roof top units providing heating and ventilation to the 1974 section of the Olathe Middle School. This project will dramatically improve the overall interior learning environment while meeting high energy efficiency standards. Fresh air and reduced carbon dioxide levels will enhance student achievement.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$395,708.06; District Contribution \$645,628.94 or 62%, with the source of match being the district's bond reserve fund.

Springfield Re-4/Safety Upgrades

This project addresses the safety and security of students at the 1958 high school and 1949 elementary school. The project will replace an obsolete fire alarm system and address access points to the buildings. Currently both buildings are access thru multiple doors. The project will provide new monitoring of the multiple access points, replace deteriorated doors and hardware and direct all visitors thru a single access point at the entry. The existing fire alarm system will be replaced in its entirety. The project will be code compliant and permitted. The project will have a construction warranty and a manufacturer's warranty on materials.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$513,515.08; District Contribution \$356,849.46 or 41%, with the source of match being the district's general fund.

Trinidad 1/ Trinidad Middle School Building System/Safety Upgrades

This project addresses health and safety concerns in the 1909 middle school building which has significant history to the community. There are concerns with the indoor air quality, a mechanical system that no longer functions as appropriate for student activities, monitored access to the facility and students, fire protection and numerous site concerns.

This project will resolve these deficiencies and enhance student achievement by providing an energy efficient mechanical system which will include addressing the building envelope in the design and will also impact the existing electrical service. The project will also reconfigure the main entry and access to the building, upgrade the fire protection system and improve site conditions and access as part of the renovation. The design of the project will consider high performance design including energy efficiency and be code compliant. The project will have a construction warranty and a manufacturer's warranty on all products installed in the renovation.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$11,040,260.73; District Contribution \$4,509,402.27 or 29%, with the source of match being the district's November 2019 bond election.



East Grand 2 – District Wide Safety Upgrades

This project addresses health and safety deficiencies including lack of secure and monitored entries. This project will resolve these deficiencies by relocating administration to be adjacent to main entries, upgrading cameras, video systems, intercoms, public address system, door hardware, and fire systems. Student achievement will be enhanced by providing a safer school environment.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$2,185,142.40; District Contribution \$5,907,977.60 or 73%, with the source of match being a November 2019 Matching Money Bond Election.

Jefferson County R-1/JeffcoNet – Fiber Network Infrastructure

This project will affect the safety and security of students. The project will provide the infrastructure to address public safety and response systems at Jefferson County R-1 front-range schools. Currently the security surveillance is at the individual schools with no connection between schools in the district. In the event of a treat at a particular school that school is the only school that knows of the situation until the media becomes involved. The infrastructure will include the ability to provide the planned one to one initiative for students. This project will allow Jefferson County R-1 schools a dedicated, high-speed communication channel between individual school locations and local public safety organizations. In addition, this routing will provide the infrastructure where the district will be able to provide students with one electronic device to assist with learning.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$2,000,000.00; District \$8,000,000.00 or 80%, with the source of match being the district's November 2018 bond and Information Technology capital budget.

Johnstown-Milliken RE-5J/Milliken Elementary School Roof Replacement

This project addresses health and safety deficiencies including ongoing roof leaks and roof deterioration, causing damage to classrooms and spaces below. The affected roofs are 20-25 years old and in poor condition. This project will resolve these deficiencies and enhance student achievement by replacing the roofs in the affected areas. The new roofs will carry a ten year warranty and will be designed for a 20+ year life expectancy.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$303,436.00; District Contribution \$910,308.00 or 75%, with the source of match being a 2019 Bond Election or the district's general fund.

Widefield 3/Elementary School, Middle School & High School Fire Alarm/Camera Upgrades

This project affects the safety and security of students. The project will upgrade the existing fire alarm systems at numerous schools and install cameras for building surveillance where there is no coverage. Existing fire alarms systems no longer work and are non-code compliant. Smoke detector coverage does not exist. With the replacement of the fire alarm systems with a current code compliant system and installation of security cameras this will provide the needed protection for all occupants of the building in a fire event and help with student issues at the schools. The district had noted numerous student issues that occurred that they were not able to address for lack of surveillance. The project will have a manufacturer's warranty which will cover construction and materials.

This project is recommended for BEST Cash funding as follows:



Grant Amount \$317,626.43; District Contribution \$457,072.19 or 59%, with the source of match being the district's November 2017 bond election.

North Conejos RE-1J – Centauri High School Replacement

This project addresses health, safety, and technology deficiencies including poor vehicular circulation causing safety issues, lack of security systems and door monitoring, lack of accessibility, mechanical systems that can no longer provide a comfortable environment, and many other challenges. This project will resolve these deficiencies and enhance student achievement by replacing the school on the same site with an educational facility that is designed to current day teaching and learning standards. Project will pursue high performance certification.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$24,224,076.15; District Contribution \$6,419,081.85 or 21%, with the source of match being a November 2019 Matching Money Bond Election.

Lake County R-1 – West Park PK-2 Elementary School Replacement

This project addresses health, safety, and technology deficiencies including security, hazardous materials, water supply, sewer service and plumbing systems, indoor air quality, heating system, structural system, electrical systems, and many other challenges. This project will resolve these deficiencies and enhance student achievement by constructing a new school on the current school site. This new school will house the pre-school through second grade students in a purpose built environment that will be LEED certified.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$20,805,668.40; District Contribution \$13,870,445.60 or 40%, with the source of match being a November 2019 Matching Money Bond Election.

Eagle County RE 50 – Berry Creek Middle School Roof Replacement

This project addresses health and safety deficiencies by replacing the leaking roof on the Berry Creek Middle School. The new roof will be a fully adhered membrane system and will include new sheet metal and roof accessories. The new roof will have added insulation improving the building's energy performance and will carry a three-year workmanship warranty and a twenty-year manufacturer's warranty. This project will enhance student achievement by making the building weather tight. Maintenance of the deteriorated roof has been a strain on the district's finances.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$300,861.75; District Contribution \$902,585.25 or 75%, with the source of match being the district's bond reserve fund.

Denver County 1/George Washington High School Fire Suppression Upgrades

This project addresses the health and safety of students by upgrading a deficient fire suppression system. The existing building has over 300,000 square feet of building area and 1,174 students. The building was designed using a previous building code that allowed for rated corridors. Current codes require a sprinkler system in buildings over 12,000 square feet. With the square footage, large number of occupants and the use of plastic products of combustion this can lead to occupant exposure and increased egress time. To complete the sprinkler system which will provide early suppression to allow building occupants to safely evacuate the building before



the fire spreads. The project will be code compliant and permitted thru the state. The project will have a construction warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$1,471,517.40; District Contribution \$2,117,549.44 or 59%, with the source of match being the district's 2016 General Obligation bond.

Pueblo City 60/Fountain International Magnet School Partial Roof Replacement

This project will partially replace an existing roof that leaks and is out of warranty which affects the health and safety of students. The district has repaired the roof, but the repairs no longer maintain a dry environment and it is now difficult for the district to determine the location of the leaks. When the roof leaks students are relocated while the district cleans up the affected area and verifies the area is dry, so no mold develops and repairs the damaged finishes. The existing roof will be removed to the deck and replaced if damaged. A new four-ply built-up roof with R-38 insulation will be installed. The project will be permitted and meet current codes and will have a construction and a manufacturer's warranty. The replacement of the leaking roof will allow the building occupants to maintain their daily activities without disruption.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$475,639.82; District Contribution \$291,521.18 or 38%, with the source of match being the district's capital reserve funds.

Westminster Public Schools/Shaw Heights Middle School Boiler Replacement

This project addresses the health and safety of students due to the age of the existing boiler system and concerns of the systems continued operation which would impact 565 students if the system would fail. This project will resolve these deficiencies by replacing the existing boiler system with a code compliant energy efficient boiler system and enhance student achievement by providing a reliable source for heating the school during the cold months. This project request is for the equipment and installation only. The project will have a construction warranty and a manufacturer's warranty for the boiler equipment.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$342,517.45; District Contribution \$280,241.55 or 45%, with the source of match being the district's restricted fund.

Mazanola3J/PK-12 Addition and Renovation

This project addresses the health and safety of the students by replacing the existing elementary school and renovating the existing 1925 historic Junior/ Senior High School and to add an addition. The existing elementary school was built when hazardous building materials were used in construction, the building systems are deficient and do not operate to provide appropriate student comfort. The secondary students travel from the Junior/ Senior High School to the elementary school for meals. The district has remote buildings that students travel to for specialized programs. The project will locate all students in one secured school building with current classroom technology. The renovation of the existing 1925 historic building will include code compliant building systems, the removal of hazardous materials and exterior work to support the new mechanical system. The addition will include a new gymnasium and classrooms for all grades and special education. The renovation and the addition design will include high performance design considerations and be energy efficient. The project will be code compliant and permitted thru the state. The project will have a construction warranty and a manufacturer's warranty for all products and equipment within the project.



This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$31,386,774.74; District Contribution \$200,000.00 or 0.63%, with the source of match being the district's reserves.

La Veta RE-2/PK-12 Building Replacement

This project addresses health and safety of students by constructing a new PK-12 school on a district owned site. The district currently owns six buildings used for educational programming. A public street divides the facilities/campus. Due to the past wildfires the district is now faced with the potential of the town flooding. The existing building systems of the elementary school do not provide reliable and appropriate heating. The 1911 high school has concerns with under-ground water and foundation deterioration. The district has concerns with the separation of the campus by the local public street and traffic thru the campus. This project will resolve these deficiencies and enhance student achievement. The new school will be raised to be above the current flood plain and accommodate a five-hundred year flood, provide for the educational programming the district offers students and provide for the security of students within a single school building. The design of the project will consider high performance design and energy efficiency. The project will be code compliant, permitted thru the state. The project will have a construction warranty and a manufacturer's warranty for products included in the new facility.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$35,978,780.88; District Contribution \$5,499,999.12 or 13%, with the source of match being the district's November 2018 bond election.

Expeditionary BOCES/Rocky Mountain School of Expeditionary Learning Building/Safety Upgrades/Addition

This project addresses the health and safety of students by upgrading the existing building systems and constructing an addition that includes programmed spaces that are not currently located in the existing building but are required for the operation of the school. The existing building systems are deficient and do not provide for appropriate heating or cooling of the facility. The building does not include a kitchen or appropriate location for students to access meals. The program requires students to do outdoor activities and they do not have appropriate locations to shower or change clothes. This project will resolve these deficiencies and enhance student achievement by upgrading all building systems in the existing building. The addition will accommodate a kitchen and a location for students to eat their meals. It will also include appropriate changing areas for all students. The project will consider high performance design and energy efficiency. The project will be code compliant and permitted thru the state. The project will include a construction warranty and a manufacturer's warranty for all products and equipment in the facility.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$4,404,556.22; District Contribution \$7,499,649.78 or 63%, with the source of match being a 30 year term, fixed rate, tax-exempt bond.

Denver County 1/Gilpin Elementary School Galvanized/Steam Piping Replacement

This project addresses health and safety of students by replacing a failing galvanized/ steam piping system. The steam piping is original to the building and is routed in the crawl space and is failing causing excessive moisture in the crawl space. This has become the breeding ground for insects, rodents and mold which are visible. There are additional concerns of the water as the water runs brown. This project will resolve these deficiencies and enhance student achievement by removing asbestos containing material and mold initially. Once the pipes are



clean the district will replace the existing piping including the domestic water system and the heating system all impacted by the failing pipes. The project will have a construction warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$3,344,136.35; District Contribution \$4,812,293.76 or 59%, with the source of match being the district's 2016 General Obligation bond.

St Vrain Valley RE 1J/District Wide Roofing Repair & Replacement

This project addresses health and safety deficiencies by replacing sections of the built-up roofing at Central Elementary School and the standing seam metal roofing at Westview Middle School. It will also provide for the recoating of the roof and repair of flashing details at Sanborn Elementary School. These three roofs were determined to be the district's most urgent roof projects. This project will enhance student achievement by providing weather tight roofs over the learning environments. The two new roofs will have a thirty-year full roofing system guarantee by the manufacturer and there will be a fifteen year warranty on the roofing restoration at Sanborn Elementary School.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$667,566.72; District Contribution \$1,418,579.28 or 68%, with the source of match being the district's bond reserve fund.

Sierra Grande R-30/PK-12 Replacement

This project addresses health, safety, and technology deficiencies including fire protection, electrical systems, plumbing systems, structural systems, accessibility, lack of secured and monitored entrances, and numerous other challenges. This project will resolve these deficiencies and enhance student achievement by replacing the school on the same site with an educational facility that is designed to current day teaching and learning standards. Project will pursue high performance certification.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$35,213,784.85; District Contribution \$13,779,307.11 or 28%, with the source of match being the district's 2018 bond proceed fund.

Ellicott 22/Elementary School/High School Safety Upgrades

This project addresses the health and safety of students by addressing the access to the facilities and to provide a high wind shelter which will serve as cafeteria space. Both schools lack monitored access at the entrance of the building. In addition, the district is located in an area that sees high winds and tornado alerts and touch downs. This project will resolve these deficiencies and enhance student achievement by providing a secured monitored entrance to the buildings where student movement will be monitored and access by visitors controlled. The project will include the construction of an addition to the cafeteria which will serve as a high wind shelter where the elementary students will gather in the event of a high wind notification. The project will be code compliant, permitted thru the state and have a construction and manufacturer's warranty for product and equipment included in the project.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$2,150,585.28; District Contribution \$836,338.27 or 28%, with the source of match being grants the district received from small rural funding, 2015 GOCO grant reimbursement, and the Colorado Department of Public Safety School Security Grant.



Adams-Arapahoe 28J/East Middle School Remodel and Addition

This project addresses the health and safety of students. The existing school is showing signs of building movement due to cracking floor slabs and shifting walls and doors. The district has concerns with security due to the eighty exterior doors and the movement of students coming and going. Due to the age of the buildings, there is known hazardous materials which has been disturbed. The building systems are deficient and indoor air quality is an issue. This project will resolve these deficiencies and enhance student achievement by demolishing two-thirds of the building which includes the areas where movement has been noted and renovating the remaining athletic building, the 1980's exploratory building and the courtyard auditorium building. A new classroom addition will be built to the west of the remaining buildings that will be code compliant and permitted thru the state. The project will consider high performance design and energy efficiency. The project will have a construction warranty and a manufacturer's warranty for all products and equipment in the project.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$17,680,732.40; District Contribution \$26,521,098.60 or 60%, with the source of match being the district's November 2018 bond election.

Mountain Middle School Roof Replacement

This project addresses health and safety deficiencies by replacing the leaking roof over the northern portion of the Mountain Middle School. This project will enhance student achievement by making the building weather tight, therefore eliminating the buckets around the building when it rains or during snow melt. The new roof will include additional insulation to improve energy efficiency and will have a twenty year warranty.

This project is recommended for BEST Cash funding as follows:

Grant Amount \$118,343; Charter Contribution \$53,168.72 or 31%, with the source of match being the charter's reserve fund.

Mapleton 1/Valley View Elementary School New School Replacement

This project addresses the health and safety of students in the existing school facility by constructing a new school on the same site as the existing school. The school is located adjacent a heavily traveled four-lane road and is separated by a parking lot. There was an incident where a car slammed into the school building and injured students. The site does not have a designated bus loop or parent drop off. The building has indoor air quality issues due to deficient mechanical systems, security concerns due to the numerous access points, plumbing deficiencies including lack of appropriate facilities due to the number of occupants in the building and deficient fire alarm systems. This project will resolve these deficiencies and enhance student achievement by constructing a new school located off the adjacent four-lane road and providing a new facility to address the districts educational programming. The new school will provide a safe and secured environment with new building systems. The project will consider high performance design and energy efficiency, be code compliant and permitted thru the state. The project will have a construction warranty and a manufacturer's warranty for all products included in the facility.

This project is recommended for BEST Lease Purchase funding as follows:

Grant Amount \$17,414,793.86; District Contribution \$6,441,088.14 or 27%, with the source of match being the district's November 2016 bond election.

To determine FCI, the total cost of remedying deferred maintenance is divided by the current replacement value. The higher the FCI the poorer the condition of the facility. The range for FY 2019-2020 is 0.09 – 0.62

Adequacy Index: Adequacy Index (AI) is a metric based on a set of questions that measures a school's compliance with set standards. The higher the AI the less the school complies with the standards. The range for FY 2019-2020 is 0.06 – 0.54

On the list below, 28 schools have FCI and associated AI, the Division of Capital Construction is actively working to replace the aging 2010 Assessment Score for Healthy Occupants with updated FCI data over the ensuing years.
