Legal Debt Margin | As of December 2, 2022

The net indebtedness of the City shall not be in excess of 10% of the state equalized valuation of all real and personal property. Obligations which are not included in the computation of legal debt margin according to the statutes incorporating the unit of government are:

- (1) Special Assessment Bonds;
- (2) Mortgage Bonds;
- (3) Revenue Bonds;
- (4) Bonds issued, or contracts or assessment obligations, incurred, to comply with an order of the Water Resources Commission (now the Department of Environment, Great Lakes, and Energy) or a court of competent jurisdiction;
- (5) Other obligations incurred for water supply, sewage, drainage or refuse disposal projects necessary to protect the public health by abating pollution.
